






ACES Consultants as of November 2023






ACES Consultants as of November 2023

8% of our consultants identify as LGBTQIA, and 5% are differently-abled.



ACES Team Demographics, By Gender




ACES Consultants as of November 2023







Omaha, NE Trip to Conduct a Site Visit of Sherwood Foundation - Radius Project

RADIUS, a non-profit organization dedicated to serving youth aged 12-18, focuses on repairing relationships among young individuals, their families, and the community. ACES secured a contract, supported by the Sherwood Foundation, to oversee the evaluation of RADIUS's youth residential program. As part of this endeavor, ACES team members, accompanied by Dr. AO, conducted a site visit in Omaha, Nebraska in late September 2023. During our time in Omaha, the ACES team toured the residential facility, engaged with the program's youth, and held discussions with RADIUS leadership to gain insights into their program and highlight the evaluation's progress. Trailhead Institute's Workforce Programs & Initiatives hosted a virtual Lunch & Learn to discuss strategies and opportunities to engage military Veterans in the public health workforce. This webinar provided an introduction to key findings, reflections, data, and opportunities that emerged from extensive review and discussions with Veterans across all branches of the military. Trailhead engaged external partners to conduct an environmental scan and national literature review on strategies to include military Veterans in the public health workforce. 


ACES President and Founder, Dr. Ndidiamaka Amutah-Onukagha, presented findings from a maternal telehealth services evaluation at American Public Health Association Conference on November 13, 2023.

The session focused on ACES' evaluation of maternal telehealth services provided by Accompany Doula Care. ACES conducted three focus groups with a total of 15 select ADC doulas and distributed surveys (n=23) to better understand current telehealth systems and practices. Focus group discussions painted the resiliency of both doulas providing maternal telehealth services, and their patients. While there were several missed opportunities in using telemedicine (i.e. barriers to care, physical touch, difficulties in labor and postpartum care), there were also several unintended benefits that arose through these conversations with doulas. Overall, doulas found telehealth services to be beneficial during this time of quarantine and social distancing.




Social Media Highlights
